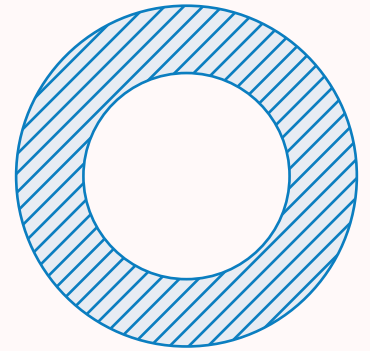

## **Master G.T. Lung, Master in Family Court**

Master G.T. Lung was admitted as a solicitor in Hong Kong in 2005 and joined the Judiciary as a Permanent Magistrate in 2020. He started his mediation practice as an accredited General Mediator and Family Mediator of Hong Kong International Arbitration Centre (HKIAC) in 2009. He was then accredited by HKIAC as a Family Mediation Supervisor in 2011. He became an accredited General Mediator, Family Mediator and Family Mediation Supervisor of Hong Kong Mediation Accreditation Association Limited (HKMAAL) in 2013. He also acquired a Master of Arts Degree in Social Work (Family-Centred Practice and Family Therapy) from the Hong Kong Polytechnic University in 2017.

Before joining the Judiciary, Master Lung was HKMAAL's mediator assessor and a trainer of accredited Family Mediation courses. After joining the Judiciary, he acted as Presiding Officer of the Labour Tribunal, Adjudicator of the Small Claims Tribunal and Master of the District Court and involved in various Court-annexed and Court-based mediation schemes, including referral of suitable cases to West Kowloon Mediation Centre as an Adjudicator of the Small Claims Tribunal, sitting as a Master of Case Settlement Conference and referral of suitable cases as a Master in Family Court to receive mediation under Family-Court Annexed Mediation Scheme. Master Lung is now sitting as Master in Family Court.
